	My family lives within the school board district 7 of which you are the elected trustee. I am writing regarding the proposed changes to school boundaries. Currently, my daughter, who is a seventh grader, attends Ben Steele Middle School. We are one of the families who are impacted by these proposed changes.
	When the proposal for school redistricting was brought up at the November school board meeting, we were not notified by the superintendent of these proposed changes via email, which has been the usual method of notification. Instead, teachers at my daughter's school were the first to discuss this proposal with her. They were the first to tell her "You are going to have to change schools again." We, as her parents, were not even given the opportunity to discuss this with her and help her to understand the options for her next year.
	I have read the proposal and reviewed the maps for proposed changes. During my review of the proposed school changes, I noted that the Olympic Village area is not included in the area for Will James, when all other areas east of Shiloh are zoned for Will James. Why is this area excluded? Who "important" within the school district lives in this area? If this area remains in the "Ben Steele zone," how do we get our daughter on this bus? Is there a form to complete or someone I am to call?
	The proposal states that students will be grandfathered into their current school. This is wonderful. The only issue is for those students who wish to remain at Ben Steele, there is no public transportation to this school. The city bus system does not go further than Shiloh. This is the only middle school that is outside of the city bus routes. This causes increased hardships for families affected by the proposed changes, and this constitutes discrimination against these students. If my daughter were in any other area of town, I could opt to purchase a city bus pass and she could transport to and from school using the MET bus. This is not an option for those who wish to remain at Ben Steele. Families would have to assume the responsibility for transportation. Unfortunately, not all families can change work schedules to accommodate transportation. I am a nurse, and my husband begins work at 6 am and drives a delivery truck throughout the region. I do not believe that it would be in the best interest of my patients to have to leave twice during my shift to transport a child. We do not have additional family in Billings and there are no public transportation options. So, our choices for our daughter are eliminated.
	I would like to request that, you make the following changes to the proposal. First, allow students enrolled in a school to finish their education at their current school and provide transportation, even if families are asked to pay a portion of that transportation cost. Second, begin proposed changes to school redistricting to begin with incoming classes of students. This allows current students to remain in their respective schools until they age out by grade. While I realize that this may also cause difficulties for families, I believe that the hardship would be less than it is in the current proposal. Another option would be for the school district to work with MET bus and develop routes that would run on school days to provide a transportation option for students who want to continue at Ben Steele.
	Our children are resilient; however, what they have had to endure in the last several years is unprecedented. Their learning has been disrupted and some may never recover academically. Some may never recover emotionally from this upheaval. Many families are still struggling with the repercussions of Covid on their households, including the financial impacts. This may be a final blow to some of these students and families. We will lose both middle school and high school students to truancy with the redistricting.
	I implore you to consider these students, their families, and the impacts another redistricting will have on them academically and socially. They have relationships built within their respective schools. They have solid relationships with their teachers and are confident at their current school. To uproot them again, even if only for a year, is more than they should have to bear and certainly more than many can bear. I understand that redistricting is inevitable. However, Ben Steele was at or above capacity when it was opened just a few years ago. The increased growth on the West End should have been factored into the initial districting lines to prevent just this situation. It is a disservice to the taxpayers who are funding the schools and most importantly to our students to continue to uproot them every few years because there was no foresight for growth.
	Is it possible to pay for busing if a student is grandfathered in? Our backyard is the boundary line between Ben Steele and Will James and I noticed that my son could still get off and on at a bus stop around the Olympic Parkway apartment complex, which would be only a block from our house. (Before he used the bus stop at Hurdle and 28th Street) I would really like to not have to upend his entire world over 10 feet. He is thriving at Ben Steele and is in many clubs with his friends and I would have no way of keeping him there unless he was able to take the bus. He is currently in the 6th grade, so we are only looking at 2 years.

All that was required was to cross Central Avenue to get there. In 2017, that changed to Big Sky. That required us to cross both Monad and 32nd Street. Now, it is proposed that we change our elementary school for the 3rd time in 5 years and cross Central Avenue and 24th Street, the busiest intersection in the State. We are also changing our middle school for the 3rd time in 5 years. Additionally, it makes no sense to me that we cannot attend the school closest to us when Meadowlark's current and proposed district includes all areas to the West, almost to Laurel. The school district is busing kids in who live several miles away when we are located to a school that is approximately 2-3 blocks away and within walking distance. I would very much like our kids to attend Meadowlark again. As a final note, these maps for Meadowlark and Ben Steele ensure that the parties living in a certain area are allowed to attend the schools that are either newer or better maintained to the exclusion of the rest of the taxpayers, including us. We are also paying taxes to employ the Cropper firm to continually re-district our area.

It is undoubted that this redistricting will increase vehicle travel and congestion in on our streets and at our schools at drop off and pick up times. Wouldn't it make more sense to maintain, or even create, boundaries that allow neighborhood students and families the reasonable opportunity to walk or bike? For the large portions of the city that are outside of walking/biking distance from an elementary school we should focus on busing students to an appropriate school since they are beyond walking/biking distance anyway.

Im terrified as to what this means for us.
		My concern centers on student access and safe routes to schools. Families who choose to live near our public schools should not be pushed out of their neighborhood schools in order to accommodate those who choose to live far away from our city's resources. It should not be incumbent on our district to keep moving resources to the edges nor to "shuffle" students out of their neighborhood schools to make room for those who are further away.
		Families that live far from resources often have to be bused regardless of their school assignment. I wish you would consider simply taking kids who are already bussed and relocating them to lower enrollment schools in the city core. Please prioritize keeping our neighborhood schools in-tact (or in some cases, return them to the neighborhood Big Sky and Central Heights for example both have large neighborhoods within walking distance that are districted to other schools). No kid who lives within safe self-transport distance from one school should be forced to attend a school further away to accommodate the "shuffling-in" from the outskirts.
		This should also be considered at the middle and high school levels. For example, the new plan includes the relocation of McKinley students to Riverside. There is literally no safe way for a student to cross the railroad tracks and transport themselves to Riverside from the NW downtown corridor yet these kids can, and do, get themselves safely to L&C.

		As a parent of 4 children, currently aged 13, 11, 9 and 4, school consistency is critical for our relationships with other students, families, and educational staff. In 2017, prior to our oldest entering middle school, we were redistricted from Medicine Crow to Castle Rock. We are now being told we will be redistricted back to Medicine Crow just 5 years later. That original redistrict move was made out of fears of overcrowding Medicine Crow, which is now 200 students below capacity. If the same analytic methodology that was used in 2017 is being used here, I have to assume based on history we will change another 1-2 times before my children are all through middle school. This is the opposite of consistency and stability, which are absolutely essential for a flourishing educational environment. My wife and I are very intentional and supportive in our involvement with our schools and our children's teachers.
		My wife and I also have serious safety concerns with the proposed redistricting. We reside on Oxbow Circle, on the north side of Highway 312, which is within 3 miles of Medicine Crow. As a result of the 3 mile rule, we are not eligible for bussing. Consequently, walking to middle school would be an estimated 45 minute walk. 1.5 miles of that walk would be along Highway 312, which does not have any sidewalk or established/maintained walking paths. Effectively, they'd be walking on the highway shoulder/easement. Upon reaching the intersection of Highway 312, Highway 87, Main Street and Bench Boulevard, there are not signaled crosswalks for our children to reach school. There is one crosswalk signal, which is to cross Main Street, from the gas station to the businesses such as Bull Mountain Grille. But no crosswalk signal for them to get out of our quadrant of the intersection.

For example, we have enrolled our student in BWHS athletic camps and attended and supported BWHS functions and sporting events.
		Please note that we recognize that all three School District 2 high schools are great, but after 5 years of built-up pride and anticipation, we have a die-hard Golden Bear on our hands who is scheduled to attend BWHS in the Fall of 2023. Thus, recent news of the possibility of impromptu redistricting is highly distressing, especially due to the fact that our student will be parted from upper class friends attending BWHS who reside in our neighborhood.

People make a lot of major life choices- including purchasing homes- to accommodate school/work schedules. A lot of kids live in 2 homes with both parents with full time careers. I can't understand why Independent kids just stay at Castlerock - it has worked well in the past. We have no control over how many people have moved in from out of state. However, we who have lived in this town for a lifetime should not be put in a position that potentially turns life upside down. Leave Independent at Castlerock - please reconsider. When our kids went to Castle Rock, they were all far enough away to receive free bus service to and from school. I am in/ near the Oxbow subdivision, north of Bitterroot, off of Hwy 312. The latest I am hearing with the redistricting is that Independent school district students "MAY* have bus service with a switch back to Medicine Crow, depending on their location. According to Google Maps, I live 2.2 miles away from the school. As I understand it, students living back in the Hidden Valley and Antelope Hills subdivisions would definitely be included on "free" bus service due to their distance being greater than 3 miles from the school. From my location, my home and many others around me would only be included IF there is room on the bus, OR if an additional bus was hired at an additional expense to us, no mention of that cost per family (and what if the family cannot afford the extra expense, what with cost of everything else increasing these days?). If the extra bus to transport ALL the students does not happen, I feel this is a HUGE safety concern, especially for those who may not have the option of getting a ride to or from school. Not only that, but either way we are within a radius of the school where we aren't eligible for bussing. So my kids would have to walk a mile farther through a much more dangerous route. 		I live at N 32nd St near McKinley School. We are significantly concerned about the shifting boundary for the small pocket west of N 27th St. (around McKinley and Pioneer Park) that is shifting from Lewis and Clark Middle School to Riverside. This will create many hardships on the neighborhood kids and seems to go directly against the "guiding principles" presented for re-districting. 1. Minimize Impact on Students.
		This shift pulls our community of students significantly further from the middle school that is very close to our neighborhood, Lewis and Clark.
		2. Make all efforts to not split identifiable communities. Our neighborhood is bound by significant roadway and rail infrastructure at 27th St and the area around MT Ave / 1st Ave. These are notable infrastructure in our community and create natural boundaries for neighborhoods. While this change may look simple on map, the reality of the surrounding infrastructure makes this is considerable hardship for getting to school. Our neighborhood friends and community are literally split down the middle now between two middle schools. The previous boundary functions far better as it does not split neighbors who live across the street from one another. The McKinley (west of 27th St) and Broadwater neighbors are closely connected communities and therefore should attend the same middle school. Similarly, the Washington and Orchard communities are more closely connected and should also attend the same middle school, Riverside.
		3. Contiguous Boundaries. Most importantly, this hardship is unnecessary because the area south of Broadwater, near Washington Elem is much closer to Riverside. It makes more sense to move the neighborhood south of Broadwater and the small triangle area south of Central to Riverside as that is much closer. It also allows that neighborhood to use the underpass and be to Riverside in minutes. While this proposed shift in boundaries to add our neighborhood to Riverside is technically "contiguous", it is a pocket area that goes all the way around the Lewis and Clark boundary to connect to the Riverside one. It's very inefficient and completely disconnected from the Riverside district. This is unnecessary when there are other parts of the south end of the Lewis and Clark boundary that could shift to the Riverside district and be contiguous and more directly connected to it. The reality of transportation from south of Broadwater to Riverside would be significantly less impactful than pulling our neighborhood that far south.
		4. Maximize Transportation Efficiency and Walkability This change runs directly against all criteria for the nationally recognized "Safe Routes to Schools" plan. These changes, per the guiding principles, should maximize opportunities to be closer to a school whenever possible. This could work significantly better and increase proximity by taking part of the Washington Elem district, which is in the range of 6-12 blocks from Riverside, and moving them rather than our neighborhood which is approximately 2-3 miles away. When considering how one would drive from our neighborhood to Riverside, the route is approximately 3.5 miles, depending on where one lives within this area. The area south of Broadwater and Central, which is directly adjacent to Riverside, is approximately 1 mile (plus or minus). It's significantly closer and safer for students to get there.
		This is such a small neighborhood pocket that is being shifted. Because it's not a major new boundary line where entire areas are being changed, it's causing significant concerns for our neighborhood. This is small pocket of students is being detrimentally impacted by now being so far from our middle school. I completely understand the need to go through this process and appreciate the difficultly of this task. I would simply ask that you greatly consider trying to improve the proximity and safe routes to schools by having the neighborhood directly adjacent to Riverside (south of Broadwater and Central Ave) go to that school rather than pull our pocket clear around the Lewis and Clark boundary to attend a school far away in a completely different neighborhood.

Not to mention the cost to the school district to have another bus route and trying to find bus drivers when there is already a bus driver shortage. There are other districts that are closer to Riverside that would make more sense than pulling kids from the tree streets/historical north side district. This decision can't JUST be about numbers of kids. This impacts entire families and their lives. Numbers might make sense on paper but the practical application of this proposal is lacking. This isn't the first time this administration has screwed up districts, taking kids from neighborhood schools they could walk to and placing them in schools that they have to be bussed or driven to. And then the school district wants to talk about how important it is for kids to get outside and exercise. I am VEHEMENTLY against this redistricting proposal and I expect this school board and administration to do better for the kids and their families.

Riverside is too far away and I do not support this proposal at all. I bought my house expecting Mckinley Lewis and Clark and Senior. Building new middle schools shouldn't change my kid to go to an old one farther away.
11/24/2022 1	Lewis and Clark Middle School, McKinley Elementary	Our current 5th grade student would be impacted by the redistricting for the 2023-24 school year by changing his anticipated middle school from Lewis and Clark to Riverside. This would increase our commute time for dropping him off and picking him up from school by 20 minutes in the morning and evening, for a total of 40 minutes per day. Much of the reason we live in our neighborhood pertains to being close to where we work, and Lewis and Clark is much closer to our work at Rocky Mountain College than Riverside. Secondly, our daughter currently attends Lewis and Clark and our son would feel much more comfortable there since he has visited the school many times during her 6-8th grade years, and knows the layout of the school and many of the teachers. Thank you for NOT changing our son's middle school from Lewis and Clark to Riverside. We live on North 31st Street, just west of the hospital corridor.
		Hello, I would like to voice my opposition to moving the middle school district boundary from Lewis and Clark Middle School to Riverside Middle School for the Northern Elevation areas (i.e. west of N. 27th St. and around Pioneer Park). This move would create a number of problems for parents and kids, including the following:
		(1) Transportation Efficiency and Walkability - Having to walk through the downtown and cross railroad tracks is more dangerous for children, as well as for parents wanting to walk/bike with their kids. For parents that need to drive, adding more traffic to the early morning commute through downtown will slow things down for both them *and* for the workers in the downtown, which already sees a significant amount of traffic in the morning. This is further compounded by the need to stop for trains when crossing the tracks.
		Beyond that, there are still some families that utilize the city bus system. There is a direct bus to Lewis and Clark via Grand Ave, and the bus stop to catch the bus is much closer for the Northern Elevation area than the bus stop to catch a bus to the South Side where Riverside is located.
		(2) Travel Time - Taking into account traveling through the downtown corridor, the average distance and travel time for families living in the Pioneer Park area will be longer than if traveling to Lewis and Clark.

Second and most importantly, Riverside is twice as far from our address, 230 Avenue D, than Lewis and Clark doubling the amount of travel time for these children. This includes crossing the railroad track or using a tunnel that regularly floods in bad weather. The district should reconsider this map and redistrict students south of Broadwater from Lewis and Clark to Riverside instead; that makes more sense logistically and geographically.

		I am a long-time resident of Billings, and have experienced several redistricting moves over the years. The current redistricting proposal imposes hardships on many of our youngest students, from Meadowlark students being moved to Miles Avenue school, which is out of neighborhood, to the proposal that will negatively impact my specific neighborhood: the Pioneer Park, Tree streets, letter streets and North Elevation. For many reasons, the proposal to move our middle school students from Lewis and Clark to Riverside makes no sense for our neighborhood. A. The proposed change forces our neighborhood students to be miles away from our middle school in a completely different neighborhood, travelling across dangerous
		infrastructure borders, with no opportunity to walk or bike to school. B. The proposed change is contrary to SD2's Guiding Principles that were presented at a recent board meeting. Here are those principles: Minimize Impact on Students
		This proposed shift pulls our community of students significantly far away from their neighborhood, when Lewis & Clark is approximately 1.2 miles away. Students aren't able to walk or ride bikes to their middle school.
		2. Make All Efforts to NOT split Identifiable Communities
		Our neighborhood is bound by significant roadway and rail infrastructure at N. 27th St. and Montana Avenue and 1st Avenue South. These are notable infrastructures in our community and create natural travel boundaries for neighborhoods. While this change may look simple on a GIS mapping system, the reality of the surrounding infrastructure makes this a considerable hardship for getting to school. Not the least hardship is the danger posed by these streets.
		With this proposal, our neighborhood friends and community are literally split down the middle now between two middle schools. (This seems to be the pattern for several areas this proposal, with west-end exceptions.) The boundary currently in place functions far better, as it doesn't split neighbors who live across the street from one another. The McKinley (west of N 27th St.) and Broadwater neighbors are closely connected communities and therefore should attend the same middle school. Similarly, Washington and Orchard communities are more closely connected and should also attend the same middle school, Riverside.
		3. Contiguous Boundaries
		Most important, the hardship imposed by this proposal is unnecessary because the area south of Broadwater, near Washington Elementary is much closer to Riverside. It make more sense to move the neighborhood south of Broadwater and the small triangle area south of Central to Riverside, as that is much closer. It also allows that neighborhood to the underpass and arrive at Riverside in minutes.
		The North Elevation, Pioneer Park and tree street area, however, is completely disconnected from the Riverside district and community. Shifting this pocket area is very inefficient for students, families, and the district and unnecessary when there are other parts of the south end of the Lewis and Clark boundary that could shift to the Riverside district and contiguous and more directly connected to Riverside.
		The practical reality of transportation from south of Broadwater to Riverside would be significantly less impactful than pulling our neighborhood so far south. As currently proposed our neighborhood students aren't able to walk or ride bikes to their middle school. Parents must navigate heavy traffic and railroad schedules to deliver their students to Rivers
		4. Maximize Transportation Efficiency and Walkability The proposed change runs directly against ALL criteria for the nationally recognized "Safe Routes to Schools" plan. This proposal, per the guiding principles, should maximize opportunities to be closer to a school whenever possible. The proposal would be more in line with this guidance by taking part of the Washington Elementary district, which is approximately 6 – 12 blocks from Riverside, and moving them to Riverside, rather than our neighborhood, which is between 2 and 3 miles away. When one considers how one would drive from our neighborhood to Riverside, the route is 3.5 miles, depending on where one lives within our area. Additionally, parents must navigate heavy commuter traff and railroad schedules to deliver their students to Riverside. However, the area south of Broadwater and Central, which is directly adjacent to Riverside, is approximately 1 mile away from the middle school. It's significantly closer and safe
		for students to get to school.
		5. Property Values and Revenue When new residents to Billings look at neighborhoods in which to settle, one of the most important criteria in choosing a neighborhood is proximity to schools. When the middle school for our neighborhood is now out of area, with a significant commute to another part of the city required to deliver students to school, the neighborhood becomes less desirable. Property becomes less desirable. Values decline. Property tax revenue declines, including the mile providing money to the school district. The proposed change of

I also understand you are not going to make everyone happy. With that, I do want to offer comment and constructive response to the proposed boundaries. I am currently in Granite Park subdivision, which is affected by the proposed changes. We are currently attending Meadowlark Elementary and are proposed to move to Big Sky. Many in our neighborhood are upset about the change (as I assume others are) for a variety of reasons. First, we have been affected in both changes. We were at Central Heights and were redistricted Meadowlark. Now, we are Meadowlark and will have to change again to Big Sky. This impacts many in our neighborhood. School is a community and it is hard to keep this community aspect when it has changed in the most recent redistricting. We are just now having kids go through the school, we have just now experienced a principal for a number of years, and just now are getting used to bus routes and other things. Changing all of that again is upsetting as now we will have to releam policies, procedures and people. Next, our neighborhood is next to several other neighborhoods which are the kids that our kids know and play with on a daily basis. We bike to each other's neighborhoods, take family walks, and host soccer practices in these areas. 		We live in the Granite Park subdivision off of Central and 52nd St. Our neighborhood was originally zoned to Central Heights but were moved to Meadowlark in 2017-2018. If this redistricting goes through as planned then this will be the third school in 6 years.
		An alternative proposal is to move the 35 kids that were going from Boulder to Meadowlark to Poly instead. They only show 85% utilization (281/329) after the proposed changes and can absorb that amount while remaining under 100% utilization (316/329). This will leave room for our neighborhood to remain at Meadowlark and still reduce the overall numbers as we only have about 20 kids. The cutline could then be drawn down 48th street from Central down to King with the zone west remaining at Meadowlark and the zone east moving to Big Sky. This would account for the increased growth from all the new multi-unit housing being built east of 48th to move to Big Sky.
12/4/2022 18	Meadowlark Elementary	Another alternative is to just leave our neighborhood zoned to Meadowlark. We are an established neighborhood with no planned growth. We are surrounded by farmland with no developments in progress and no land for sale. We conducted an internal poll most all residents have said they will grandfather their kids to remain at Meadowlark. This would not alleviate any overpopulation at Meadowlark and instead make it worse with the added kids from Boulder.
		To whom it may concern:
		We live in Granite Park subdivision that is on the corner of 52nd Street and Central Ave. We are JUST south of Central, which is the cutoff boundary for next year's redistricting plans. The proposal for 2023 will force us to switch elementary schools, once again. If this plan is approved, our neighborhood will have its 3rd elementary school enrollment in just 7 years.
		Now this may not seem like much to an outsider, but constantly uprooting our lives, routines and processes is of utmost concern to us.
		While we understand that the redistribution of students is essential in our areas, we respectfully ask that this specific boundary be reconsidered to spare us. We feel like the same population concerns could be addressed if the redistricting boundary were to instead be moved to 48th St W. The cutline could then be drawn down 48th Street from Central Ave to King Ave with the west zone remaining at Meadowlark and the east zone moving to Big Sky. Additionally, the 35 students that were slated to move from Boulder to Meadowlark could instead be moved to Poly. Poly only shows 85% utilization (281/329) after the proposed changes and can absorb those children easily, while still remaining under 100% utilization (316/329).
		If this is an unsatisfactory option, perhaps we could just be spared and be allowed to remain at Meadowlark. Our neighborhood is established and at capacity. There will be no more growth. We are a tight knit community of friends, classmates and teammates. Our families are invested in this school and involved. In fact, the entire Meadowlark PTA governance resides in our subdivision. This redistribution will affect not only our families, but all the Meadowlark School planning committees for years to come. These current (and future) plans have been established by families that committed to be involved in this school throughout their children's elementary careers at Meadowlark.
		Additionally, I am an admin for our Granite Park Facebook page and I recently polled our neighborhood to investigate other household future plans. Data collected from that poll shows that not one family in our subdivision is planning to enroll their children in Big Sky. We have been told that we will lose bus access if we choose to stay grandfathered at Meadowlark—but yet every parent that responded plans to drive their children to and from Meadowlark instead of opting for a possible bus option to be added at Big Sky. This poll affected 35 children. This clearly will only add to to the overcrowding issue at Meadowlark for years to come and, in the meantime, inconveniences our families in a massive way. However, this is an inconvenience that families are willing to take on —just to avoid uprooting our lives for the third time in 7 years.
